Please Note:

- The Tennessee Valley Fair requires ALL commercial vendors to have \$1 million liability insurance through a master policy. If you have a current policy, you will need to list the **Tennessee Valley A&I Fair, SMG, and the City of Knoxville as additionally insured**. The Fair must receive a COI from you or your insurance company no later than September 1st, 2017. If you do not have a current policy, you may purchase one through the Tennessee Valley Fair for \$130.
- Exhibit space is subject to availability. All decisions to select a commercial vendor and contract for exhibit space shall be at the sole discretion of the Tennessee Valley Fair.
- All applications will receive due consideration.
- The \$100 non-refundable application fee must be submitted at the same time as this application— no exceptions. If your application is approved, and you are issued a commercial vendor contract, your application fee will be applied towards the final cost of the booth space rental.
- If your application is approved and you are issued a vendor contract, you will be required to make payment in full no later than fourteen (14) days from the date the contract is issued. The Fair DOES NOT accept partial payments.
